

ADVISING LEADERSHIP TEAM MEETING NOTES

Monday, March 14, 2022

Professional Development Fund-Usage – Can rollover into 2022/23- approvals & planning next

- L. Vega shared that the Professional Development funds for ALT were approved to rollover into next year.
- Live updates were made to the document containing the approval and the steps needed to be followed for the disbursement of funds. L. Vega will pass along the document once the necessary changes have been made to the document.
- L. Vega will pass along a Qualtrics survey to get an estimate of who will be using the funds and to have an estimate of how much of those funds will be used and if there will be any leftover.

Advising – Update from Statewide Meeting: No scheduled meeting

- There was no statewide meeting.
- L. Vega shared that the *Common Course Numbering System* has passed, articulating a common course numbering system in the community colleges by 2024 ([AB111](#)) and coordinating efforts to align with CSU and UC ([AB928](#)) [to aid transfer efforts](#). This means that community college, UC, and CSU courses will need to align in terms of course numbers, initially for the 20 biggest majors. He also shared that those with military experience or other experiences may be deemed eligible to receive *credit for prior learning*, which the system is working to expand to reduce time to degree.

Digital Advising Solutions per GI 2025

- L. Vega shared that they have yet to pass along the document containing the digital degree roadmaps that were deemed the best option for the campuses to adopt; however, for CSU Bakersfield it is looking like it will be RunnerConnect.

Academic Advising Policy Updates

- L. Vega shared that at the Academic Senate discussions have taken place on what constitute high impact practices and issues of the need for testing centers to stop plagiarism. Advising Task Force ATF

- Y. Morones shared that the ATF's first official meeting will take place two weeks from now, and as the ALT representative she will bring back updates to the group.

Administrative Unit Assessment for ALT

- The group members shared where their respective schools stood with respect to the Assessment of their schools advising system. It was agreed that to meet their local needs and account for their local practices, each School will work on their own administrative-unit assessment and bring back to ALT to align processes and policies so it can be shown that all students are receiving a consistent academic advising experiences. L. Vega noted this needs to be in place this term.

- L. Zuzarte shared that the preliminary catalog would be published by March 23rd.
