Misconduct in research	Contact Department Chair, then Dean. If necessary, contact the Associate Vice President for Grants, Research & Sponsored Programs (GRASP)
Grade Appeal	Follow University Grade Appeals Procedures: visit the Academic Program's Complaints and Grievances website , or contact the Office of Academic Programs, Education Bldg, Room 242, or (661) 654-3420
Complaint alleging the CSU has violated one or more state laws, where there is no other applicable CSU complaint procedure	Contact the Office of the President at (661) 654-2241
