The process includes updating degree outlines and course labels to reflect the new numbering system. It is anticipated to have the templates ready for review within the next week or two. The catalog change deadlines have a tentative date of mid-February.

- ii. Kelly explained that the oral communication learning community focuses on belonging in a world of AI and how oral communication can help students feel engaged in the classroom. Faculty members were asked to implement two new oral communication strategies in their courses and set personal goals for fostering a sense of belonging.
