I. CALL TO ORDER

Chair Paul Newberry, still swallowing hash browns, called the meeting to order at 7:58 AM. The order of events in the meeting was altered in order to accommodate several scheduling conflicts of members.

II. APPROVAL OF MINUTES

III. ANNOUNCEMENTS

- **A. Next RERC.** Isabel Sumaya has been appointed the next RERC, effective 01 June 2015. She was thanked by members for taking on this position. Sumaya indicated that she has begun periodic orientation sessions with the current [lame duck] RERC.
- **B. Gwen is Back.** Gwen Parnell was welcomed back from her recent surgery and complimented for her effective work on behalf of the IRB.
- C. Qualtrics. Qualtrics is up and running for IRB protocol submission and review. Parnell indicated that it is working pretty well, although there is a learning curve and there have been a few bumps. McCleary noted that submission of protocols via Qualtrics seems easier as compared to the old procedure. RERC noted it is still a bit cumbersome on the receiving end for protocols. The long "response ID" of each incoming protocol cannot be replaced with something meaningful. Members offered several ideas for possible functional improvements.

7-03-2014. Charles Lam. Increasing Engineering College Success and Career Readiness in the High Needs San Joaquin Valley: Engineering Education Partnerships Impacting College & Careers (E²PIC²)

RERC explained that this action was requested to satisfy a requirement of the granting agency in order to clarify the IRB status of this grant proposal. Velasquez moved, Schultz seconded, 6-0.

G. New Protocol Reviews [none]

H. Continuing Review and Renewal of Authorized Protocols

1. Protocol 07-91 Report. "Evaluation for Kern County Children and Families Commission [KCCFC]" with J. J. Wang. Primary readers were all members.

The PI summarized. F5K has been operating for 15 years with the PI involved for the past 5 years. Site visits will resume after the excitement of assembling the F5K yearly report to the State. The Early Intervention Program has ceased to operate. CSUB internship placements continue, but the final count for Fall 2014 is still up in the air.

[Q = question, A = answer, C = comment]

- **Q:** How are the CSUB internships set up? **A:** CSUB is notified and posts them using the routine procedure.
- Q: What happened with regard to the follow-up that we discussed at our June 2014 meeting? A: This is related to outcome measures and accountability and providing a memo of support from the IRB for the PI's assessment activities. McCleary was charged with coordinating with the PI and will do so.
- **Q:** What is the incident of the lost consent form about? **A:** PI summarized the incident of the vehicle break-in and stolen briefcase during a series of home visits. New procedure is that consent forms will not be left unattended.

When there were no more questions, the PI stepped outside. There was a motion to approve the quarterly report for Protocol 07-91, Gamboa moved, Schultz seconded seconded, 7-0 [Herndon had departed].

When the PI returned, he was informed of this and commended for his continuing good work related to subject protections for the F5K agencies.

2. Edvention Partners and Related. With Randy Schultz. Primary readers were all members.

Schultz summarized. They have been awarded a substantial new grant to continue these and related activities.

Protocols 10-57 & 13-84. A small group of doctoral students has been added. This involves additional surveys and focus groups. Some of the EdD students have collected these data, which has led to a report on the TED Fellows, with a conference presentation and possible publication in the works. Protocol 11-66. This protocol has been completed and will close. Protocol 11-68. This protocol on iPad use was the late Penelope Swenson's and will close. Protocol 11-117. Frustrating glitches continue accessing the required student achievement data. Some districts are cooperating. The lesson is not to wait until the end of the programs to work on accessing such data; this has been corrected in the new grant. Protocol 11-122. The administrative leadership protocol has been closed for a while. Protocol 13-117. There was a positive reaction to the anti-bullying workshops. These will be repeated this year with more data collection. **Protocol 14-05**. This is the "co-teaching model" and self-efficacy of teacher candidates. Another assessment instrument has been added. A publication is in preparation. Protocol 14-70. This involves self-efficacy of pre-service teachers related to the Lamont STEM summer activities. Protocol 14-93. This was recently approved and covers effects of the STEM summer camp on student achievement and attitudes about science. It appears that both of these measures go in a positive direction with STEM summer camp participation. Potential benefits of having the Lamont kids on a college campus were discussed.

Board members had no questions. Schultz was invited to leave and the Board deliberated in executive session. There was a motion to approve the quarterly report, and renew Protocols 10-157/13-84, 11-117, 13-117, and 14-70. Gilchrist moved, Velasquez seconded, 5-0 [Duran and Newberry had departed; the RERC was enlisted from the alternate IRB member pool to preserve a quorum].

When Schultz returned he was informed of the result, complimented on a good job, and encouraged to keep it up.

RERC noted that since the consent and interview would be face to face, the IRB waived external review of the written Punjabi materials.

2. Protocol 14-83 [Steve Bacon, Psychology, & Kris Grappendorf, PEAK] "Evaluation of the Runner Wellness Couse" Submitted 9-10-14; authorized 9-12-14 following exemption from full review.

This protocol was good as submitted, except that Grappendorf needed to do Human Subjects Protection Training, which she promptly completed.
