# V. FULL BOARD REVIEW PROTOCOLS [2]

A. Protocol 23-196, Brittany Beck - Assessing the Impact of Global Citizen Science Learning Modules

After introductions, the PI provided an overview of the project. After a discussion and questions of clarification asked of the PI, the protocol was approved with the conditions. listed below.

- 1. Add more detail about the number of interviews and focus groups.
- 2. Add that you will use pseudonyms at all times for the protection of identities.
- 3. Since informed consent will be given at the beginning of the course, provide a reminder to participants about the study and participant rights and provide paper copies of consent form.
- 4. Make clear that interviews and focus groups will occur after the course is completed.
- 5. To deal with possible issues of undue influence, add that you will not be the one to conduct interviews and focus groups.
- 6. Make sure to add research personnel that will conduct the interviews and focus groups along with their human subjects training (CITI).
- 7. Before you can use the NOVO ED platform, you must have CSUB IT approve its use.
- 8. Add Nat GEO representative to the protocol along with their human subjects training (CITI) as they will have access to data in NOVO ED.

Votes: Stark motioned to approve, and Olson seconded (8-0-0).

B. Protocol 23-197, Yong Nathan Li, Co-PI Tzu Fen Chang-Risk and Protective Factors for Suicidality among Asian College Students

After introductions, the PI provided an overview of the project. After a discussion and questions of clarification asked of the PI, the protocol was disapproved as the risks to participants outweighed the benefits.
