CALL TO ORDER

Interim Chair Williamson called the meeting to order at 8:07 am.

APPROVAL OF MINUTES

Stark motioned to approve the minutes, Cheshire seconded, (6-0-0).

ANNOUNCEMENTS

AVP for GRaSP Search. Sumaya let the board know that she will be taking on the role of interim AVP for GRaSP while keeping IRB responsibilities.

Update on IRB revised policy. Sumaya thanked the board for reviewing and approving the revised IRB policy document on such short notice. This was in response to a CSU audit of the Pre-Award GRaSP unit and the need to update the policy to bring us into compliance. One major change in policy was doing away with the senate vetting board appointments. This was a needed change given the senate did not feel it was the appropriate body to review and approve the document. Also, Parnell shared that IRB membership is now in line with federal regulations (at least one in each area instead if three) and the New Common Rule Exempt categories seven and eight were added. The committee will take the steps needed to be in compliance with their own internal policies. Parnell also mentioned there is a checklist of recommendations from OHRP that she and the RERC are methodically going through which will be added to the policy this summer.

New IRB meeting dates. Williamson asked the committee to double check whether the Wednesday dates will be at the end of the semester for both fall and spring. Stark let the board know that they need to encourage the submission of protocols and get people to convert their summer work immediately into protocol submissions. Williamson mentioned the possibility of

having more frequent full board review meetings, maybe once a week or every two weeks so people can submit protocols when needed. Sumaya suggested procuring stipends for

those that want to participate in the IRB during the summer and maybe have one full board meeting for the Summer. Livingston motioned to approve meeting during summer, Wilson seconded, (5-0-0).

Livingston mentioned keeping data safe because files may get corrupted. Stark mentioned encouraging multiple backups but asking for reports on what they are doing to keep those files safe. Livingston motioned to approve a new storage policy, Stark seconded, (5-0-0).

- 1. Section 3. #1: Provide a detailed description of the dynamometer in the background section citing that it is a commonly used measure of strength levels.
- 2. Section 3. #2: Make justification for using children and is your goal connected to fear of injury? If so, state it here. And, add a statement about the "drop out effect" that you talked about in the meeting as further justification for the choice for the age of participants.
- 3. Section 3 #3. What is known and unknown about gymnast being more injury prone than other groups.
- 4. Please include in your recruitment materials that participants must have had an injury (and the type of
- injury). And in the protocol describe exactly how you will recruit (do it in facility before practice...etc.).
- 5. Section 4. #1: add the inclusion info on having a previous injury and exactly where the injury was (hand versus leg?).
- 6. Section 4. #12b.: Need to include info here on how you will tell the participants and their parents/guardians that they need to contact their Primary Care Physician for care if need be. Also, please provide info on where parents can seek free online psychological services if need be. Please also add this info to the parental consent form.
- 7. Include an assent form for the children. Make sure that you write it at the level that they will understand what you are asking the to do in the study. Also, make clear in the protocol and in the parent consent form that you will be providing the children an assent form.
