I. CALL TO ORDER

Chair Paul Newberry called the meeting to order at 8:01 AM.

II. APPROVAL OF MINUTES

The faculty sponsor for 14-67 has been corrected in the Master Log and 13-117 will be moved from closed to renewed. Thus corrected, the minutes of the previous meeting on Friday, 03 October 2014 were approved, Duran [of course] moved, Velasquez seconded, 7-0.

III. ANNOUNCEMENTS

- **A. Welcome Colleen McGauley.** The new community member was welcomed to the fold. There was a round of introductions.
- **B. Report on 2015 CSU IRB Forum.** Gwen and Isabel recently attended this event. Useful people networking happened at the meeting. Gwen's comprehensive summary of the important points was included in the meeting packet and summarized. Several CSU's are interested in new software packages to process IRB records. Debate continues on reviewing oral history research at CSUB, we review. The trend over time appears to be to review fewer kinds of research activities. Federal revisions may strongly encourage this when completed. There was a wide-ranging [and intense at times] discussion at the forum on whether, and

how, student research should be reviewed by IRB's, including the operational definition of "generalizable knowledge". CSU mandated reporting policy is an issue for researchers and may be revised. Some IRBs have departmental sub-committees and some CSU's have IRB's made up of students as training experiences. Should we have a "Best IRB Submission" award at the upcoming Research Excellence event in April? No, but we will discuss this at the next IRB meeting.

IV. OLD BUSINESS

A. Qualtrics. This has been up and running since September 2014. Faculty complaints have diminished. This is very user friendly for submitters, requiring no log in or training, but is not a fully automated IRB document processing system.

F. New Protocol Reviews

1. Protocol 15-11. "Muslim Americans on Homosexuality: Is Everyone Truly Welcome?" with Hala Alnajar and Rhonda Dugan [Sociology]. Primary readers are Duran, McCleary, and Velasquez.

Following introductions, the investigators summarized. Semi-structured interviews with Muslim persons in Kern County and Los Angeles County will explore attitudes about homosexuality, with a focus on the potential conflict between the teachings of their religion and changing social values. The student is not new to this topic, has training in qualitative research methods, and enjoys some entry into potential subject populations. They will be aiming for 20 interviews, which is fairly high for this kind of approach. Questions followed.

[Q: Question A: Answer C: Comment]

Q: Is this about comparing conservative vs. liberal perspectives? Will you be looking for sub-groups reflecting this? **A:** Interviewees will not be selected on this basis, but this breakdown may help make sense out of the data.

Q: Will everyone get the same questions? **A:** Yes, but there is some flexibility because these will be semi-structured interviews.

Q: Will you do all of the interviews? A: Yes.

Q: Why are you requiring that participants be citizens? **A:** This provides a clear-cut definition of the population studied in order to clarify the limits of generalizations.

Q: How about the ages studied? **A:** It will vary. Older Muslims may be more conservative.

Q: Do you have a list of questions? **A:** Yes, that is attached to the protocol.

Q: How will you approach the data analysis? **A:** We are still working on that, but in general we will look for patterns in the interview data using a "grounded theory" approach.

Q: What about the interest in conservatives and liberals? Do you have hypotheses about this? **A:** Not really hypotheses, but the existing research comes from a liberal Muslim population.

Q: How will you recruit participants? **A:** It will be "snowballing", starting with initial contacts and from them to others, and so forth.

Q: Does this mean that you will be primarily interviewing people you know? **A:** Actually not, this will be avoided to minimize bias in the sample and reluctance of persons to respond candidly.

C: Existing research on conservative vs. liberal Christian views on homosexuality might help you refine your thinking on your topic.

C: Gender might be an important variables in your research.

Q: Might how important your religion is to you be an important thing to discover? **A:** We will look at that.

C: You need to confine your own expectations and beliefs when you do the interviews to get useful data. **A:** Will do.

Q: Might you end up with a disproportionate representative of LGBT participants? **A:** Actually, that's unlikely in Kern County, at least – there is no LGBT Muslim community. However, interviews with LGBT Muslims could yield useful info and we could modify our questions accordingly for such participants.

Q: Would it make sense to include LGBT Muslim Allies at CSUB as referrals? **A:** [from an IRB member] There aren't any.

Q: You are a female unmarried Muslim. Will this restrict access to males? **A:** Yes. Probably won't gain access to Yemeni Muslim males, so probably will have a primarily female sample.

Q: How will you do referrals in case of distress or "coming out"? **A**: See the consent form for sources.

C: Please include the list of LGBT resources in the consent form, so they will be available.

C: Concerns were expressed for the safety of the researcher. **A:** She has lots of experience in this area and has gotten no backlash so far.

When there were no more questions, the investigators were invited to leave and the IRB deliberated in executive session. There was a motion for conditional approval of Protocol 15-11. Authorization included addition of an optional additional set of questions for persons who identify as LGBT. Gilchrist moved; Velasquez seconded, 7-0. The conditions were:

- 1. Include the specific LGBT resources in the consent form.
- 2. Describe in more specifics the framework of the data analysis.

The investigators returned and were so informed. They were complimented on having submitted a well-thought-out protocol that required few conditions for approval.

G. Continuing Review and Renewal of Authorized Protocols

1. **Protocol 07-91**. "Evaluation for Kern County Children and Families Commission [KCCFC]" with J. J. Wang. Quarterly Report. Primary readers are all members.

The PI summarized. The current funding cycle is concluding. There are no violations. Fewer people smoking reduces funding, so budgets of F5K agencies have been cut. Site visits and so forth continue.

[Q: Question A: Answer C: Comment]

Q: It seems like the IRB element in F5K has become "institutionalized". **A:** Yes. CSUB IRB was lauded in poster presentations and may be helping.

Q: Our IRB expressed support for more assessment focused on actual outcome changes. How is that working out? **A:** It varies. Emphasis is on being "cost effective". There are 3 "tiers" of accountability: [1] delivery of services [2] how well the services are provided, and [3] the effects of those services.

Q: So, the IRB asked for more emphasis on "Tier 3" data – how health of children is affected by the programs. How is that going? **A:** Good question. The state commission does not seem all that focused on Tier 3 level evaluation of programs.

Q: So, how about our concern about getting more Tier 3 evidence on program effectiveness? **A:** [PI describes some data from their yearly report, but it is not clear how these are Tier 3 evidence of program effectiveness. These seem to deal with delivery of services, not effects of those services.] PI states that academic performance scores increased in some cases with delivery of the services, which would be Tier 3 evidence.

Q: In the yearly report, is the Tier 3 evidence clearly identified so a person could easily locate it? **A:** Yes

When there were no more questions, the PI was invited to leave and the board deliberated. There was a motion to accept the quarterly report for Protocol 07-91. McGualey moved; McCleary seconded, 6-0 [Duran had departed].

2. Edvention and Related. With Robin Valente. Quarterly Report. Primary readers are all members.

Valente summarized protocol by protocol. In future submissions the protocols that have been closed will be omitted from the report to the IRB.

Protocols 10-157/13-84. Two doctoral students have data that will be presented at a conference.

Protocol 11-117. They finally have some data, which they are now examining.

Protocol 13-117. Working on an article about the bullying program.

Protocol 14-05. The co-teaching model continues and data are being summarized. This protocol needs to be renewed.

Protocol 14-70. Involves training of beginning teachers on classroom management via professional development and then placement in a classroom.

Protocol 14-93. These are STEM-related pre/post assessment of summer camp and they are seeing some positive changes.

Q: Is this part of a migrant program? **A:** Yes

Q: Funding for this? **A:** It's from many sources, but none private at this time.

When there were no more questions, the investigator was invited to leave.

There was a motion to approve the quarterly report and renew Protocol 14-05. Duran moved; Herndon seconded, 7-0.

The investigator returned and was so advised.

VI. OTHER CONCERNS:

A. Controlled Substances in Research

A CSUB committee working on revisions to the CSUB Handbook may suggest a formal CSUB policy on the use of controlled substances ["scheduled drugs"] in research. This may lead to a new committee to oversee such use and will certainly heavily involve the Office of Safety and Risk Management at CSUB. However, the CSU-Fresno policy, which was attached to the agenda, includes a section specifically addressing human research. If implemented at CSUB, this would require that any such protocols undergo either expedited or standard review. There appeared to be a consensus of board members that standard review would be appropriate, but no policy decision was made at this time. The distinction between

the interests of the IRB to protect human subjects and the interests of the university to guard against liability was emphasized. It was noted that, even in the absence of such a policy, the university has the power to forbid a research activity that the IRB has authorized. It does seem that any formal policy would require that the CSUB IRB at least share information with other elements of the university when considering a human subjects protocol involving a controlled substance. McCleary, the point of contact on this issue, will communicate the willingness of the IRB to join in discussions on this matter.
