- IV. Old Business:
  - a. Referral #30 CSU Generative AI and Professional Ethics
    - Revisions to Faculty Definitions and Al Use in Instruction
      - Proposed amendment to Section 108 of the Handbook (faculty definition) instead of Section 303.1.1
      - Defined a faculty member explicitly as a human in the early part of the Handbook for procedural clarity.
      - Agreed that professional ethics and AI use by faculty may be more appropriate in a separate section.
      - Discussed the difference between the administrative definitions of faculty roles and the guidelines for faculty behavior in relations to AI use.
    - Discussion on Automated Courses
      - Alex for chemistry and AI tools for writing lab.
      - Confirmed that using AI teaching tools does not violate the discussed guidelines.
    - Al transparency
      - Concern about lack of transparency in implementing AI tools like ChatGPT and impact on students.

- There is a need for a clear vision of implementing AI tools and investment in AI, where other services like student mental health also need investment
- Discussed the need for faculty union participation in policymaking and emphasized the importance of due process in decision making.

#### Task Force in Al Use in Academia

- Proposed the formation of task force to develop guidelines for the professional and ethical use of generative AI by faculty.
- Discussed the task force composition, proposing a sevenmember team: one faculty member from each college, a faculty librarian, an at-large faculty member, a department chair, a staff member, a member of the IT department, and a scholar specializing in the ethical use of AI.

- Dr. Tsantsoulas will present the proposed composition to the Faculty Affairs Committee for approval.
- Determination will be needed if members will be selected by elections of appointments.
