There was an addition of "Other Conduct of Concern" language to the resolution. The committee discussed adding the ombudsperson due to feedback provided at the academic senate, however, FAC did not include this language as the ombudsperson's role should be separate and independent. Minor changes were made based on feedback from the first

reading. Amber motioned to approve sending the revised version to second reading; Najmeh seconded; one abstention and all others approved.
