 - We made the decision early in the discussion to send a report of this discussion to next year's FAC. But we felt that this policy deserved additional time and consideration.
 - There are some conflicts between different sections of the handbook regarding this topic. The future FAC will need to look into these.
 - Regarding grievances between candidates and possible unit committee members:
 - We discussed options for how to eliminate a person from a
 possible committee pool due to a grievance with that
 person without outing anyone. There are many reasons

- including heavy service loads for people to be excluded from a committee pool.
- Not clear if there is a process for how to have that person excluded from the committee.
- We also discussed the number of committees that each department may need with this resolution as written. Might need to refine this further.
- Rank order voting was recommended to determine the composition of the unit RTP committees. This might be difficult without software.
 - Perhaps, we should continue allowing departments to choose how this is done.
- Ultimately, we recommend that next year's FAC should take some of these finer points and concerns into consideration next year. We recommend evaluating the principles that are important to the RTP process. This will help determine which aspects of choosing an RTP committee should be uniform across departments, and which should have additional flexibility that can be determined by individual departments.
- This will likely be taken to DCLC for input by next year's FAC.
