- I. Call to Order and Tejon Tribal Land Acknowledgement
  - a. Chair Danforth called the meeting to order at 10:02 AM and read the Tejon Tribal Land Acknowledgement. Chair Danforth also reminded Senators and guests of the code of conduct and Roberts Rules. Dr. Aaron Hegde has been appointed per the Senate bylaws as Senate Parliamentarian for this meeting and Senator Lam will serve as timekeeper.

- III. Announcements and Information
  - a. President's Report V. Harper (Time Certain: 10:10 AM)
    - i. President Harper requested a moment of silence for the passing of a Chemistry faculty member, Dennis Harvey.
    - ii. President Harper acknowledges the challenges facing CSUB right now and reaffirmed that he is committed to radical transparency and ensuring the safety and well-being of every student.

- iii. President Harper recapped on a memorandum that went out to campus on October 7, 2025 announcing that a lawsuit (case number <u>25STCV29350</u>) was filed in Los Angeles County on Oct. 7, 2025, by two former members of the CSU Bakersfield softball program. The lawsuit names CSU Bakersfield, the CSU Board of Trustees and a former softball coach as defendants. President Harper introduced Chief Mari Gonzalez, AVP for the Division of People and Culture L. Blodorn and AVP for Faculty Affairs, D. Boschini, who would be presenting information regarding the concerns with athletics and the investigations.
- iv. Chief Mari Gonzalez shared an overall view of the University Police Department's involvement in the Kevin Mays investigation. The Chief of Police stated that UPD had no knowledge of human trafficking until August 29. She also stated that the person being trafficked had no ties to campus. An anonymous tip received by a staff member was forwarded to UPD on August 29; UPD contacted BPD, and K. Mays was taken into custody within five days. Subsequently, BPD's investigation resulted in additional charges related to Child Sexual Abuse Materials (CSAM) and CSUB learned of those charges when they were made public by BPD. In spring 2025, in connection with the larger softball investigations, UPD was notified of a rumor that Mays and the student were involved in a relationship and a rumor that K. Mays and the student were selling guns and drugs. UPD conducted several interviews, and this information was shared with both BPD and the FBI. Multiple police reports were generated by UPD and other agencies regarding various aspects of the softball investigation. No evidence was found during interviews in spring 2025 to substantiate any relationship between K. Mays and the student athlete or to indicate that they were involved in any criminal conduct together. None of the reports generated in spring 2025 related to alleged criminal conduct by K. Mays.
- v. VP for the Division of People and Culture, L. Blodorn stated that at the time they were investigating the incidents and issues in softball, there were no facts or evidence, it was just rumor. L. Blodorn discussed how she was responsible, along with E. Poole Callahan and D. Boschini, for conducting the primary non-Title IX DHR non-civil-rights aspects of the investigations with softball. Herself and E. Poole Callahan interviewed nearly two dozen people, some multiple times during the time frame from March 12 to April 11. They interviewed both current and former students, staff, coaches, Kevin Mays, as well as several parents. Despite the rumors, there was no evidence or factual basis sufficient to justify placing K. Mays on administrative leave.
- vi. AVP for Faculty Affairs, D. Boschini stated that the request was made in spring 2025 by athletics and K. Conder to move K. Mays from a staff to unit 3 faculty coach position. Typical hiring procedures ensued, including a background check, which came in on March 20 and resulted in no items of concern. On May 14, the remaining paperwork to complete the hiring packet was received and with no criminal activity substantiated, the hiring process moved forward with K. Conder's approval. On September 4, when they heard of the arrest of K. Mays, they moved quickly with termination and September 4 was his last day as a paid member of CSUB.
- vii. President Harper expressed deep concern over the smearing of the names of the women involved including Chief Gonzalez, L. Blodorn, D. Boschini, and E. Poole Callahan and affirmed confidence in their work and character, as well as appreciation for their attention to detail, commitment, and work for the betterment of the institution. Moving forward, there will likely be an additional lawsuit, which they are prepared for. They have engaged a crisis expert

to help protect their brand as an institution. President Harper will continue to be on TV and in public to continue repair of the reputation of the institution and advocate for runner spirit everywhere. The President's Commission on Intercollegiate Athletics will be launched next week and will be co-chaired by faculty member, Kris Grappendorf, and community member, Shelly Carlin, who will lead a review of the athletic program and make recommendations back to the campus. Their goals will be to oversee what structures need to be in place to improve the culture of the program to ensure that athletics is fully integrated into the university. There will be town hall on Friday where they will deliver this presentation and take questions from the community. President Harper also stated that he must "continue to clean" to ensure that student athletes are safe and that the campus environment is safe.

#### viii. Q&A and Discussion:

- Senator Stokes asked about transparency between the commission and Senate and what the plan is for moving forward. President Harper responded that he expects the Senate to request both co-chairs to come to the Senate body and report at any time. President Harper confirmed that neither he nor the athletics director will sit on the commission, however, VP for SASEM, Dr. Cantrell will.
- 2. Senator Lauer commented on how the human trafficking arrests in Kern County are very high and expressed deep concern and skepticism that K. Mays was not identified earlier. Senator Lauer also stated disagreement for why Thomas Hardt was not allowed to attend Senate. President Haper responded that CSUB has engaged with two local community organizations as it relates to human trafficking, the Open-Door Network and Lawrence Skidmore. They will be creating a human trafficking and sexual exploitation hotline that will be made available to all students, which will include resources such as counselors it will be promoted at student events, orientations, etc. There will also be training provided to all students, faculty, and staff as it relates to human trafficking and exploitation. Chief Mari Gonzalez stated that law enforcement requires cause and proper authority to obtain warrants; so while rumors were received, they lacked substantive backing to allow for further investigation until August 29. Chair Danforth addressed the concern regarding Thomas Hardt, explaining that his attendance was not permitted because the Senate meetings are not subject to the Brown Act.
- 3. Speaker's list was held until Open Forum due to Time Certain for D. Cantrell. President Harper reminded the audience of the Town Hall scheduled for Friday, which would be open to the community.
- b. VP for Student Affairs and Strategic Enrollment Management (SASEM) D. Cantrell (Time Certain: 10:30 AM) (handout)
  - i. D. Cantrell presented enrollment updates and trends. See attached document.
  - ii. O&A and Feedback:
    - 1. President Harper thanked VP Cantrell, the Professional Advisors, and faculty advisors for their hard work. Special thanks were also given by D. Cantrell to the campus marketing team for their efforts regarding imaging and branding.
    - 2. Senator Lauer asked how the conclusions about enrollment were drawn given that the COVID years had such a large impact on students. VP D. Cantrell responded that he is presenting the data as collected and there were other things happening, such as

- students were given thousands of dollars to stay in school and were not dropped for over two years, which is an anomaly and not common practice.
- 3. Vice-Chair Solano asked if the organizational charts had been updated and if the slide deck he provided could be shared and included in the Senate agenda packet. D. Cantrell confirmed that the organizational charts have been updated and are posted on the webpage and that yes, the slides could be shared and included in the Senate agenda packet.

### IV. Approval of Agenda (Time Certain: 10:05 AM)

a. Chair Danforth called for a motion to approve the agenda as presented. Senator Zenko motioned to approve; seconded by Senator Grombly. Senator Lauer raised an objection. Chair Danforth called for a vote on the motion to approve the agenda; 17 votes in favor and 4 votes against. The majority in favor; agenda as presented approved.

#### VI. Resolutions (Time Certain: 10:45 AM)

- a. Consent Agenda: no items.
- b. Old Business:
  - i. RES 252603 Double Major Policy Changes AAC (Hold; in subcommittee)
  - ii. RES 252604 Minor Policy Changes AAC (Hold; in subcommittee)
- c. New Business:
  - RES 252605 Reaffirming Shared Governance and the University Handbook as Policy EC (handout)
    - 1. Chair Danforth and Senator Zenko presented the resolution for first reading.
    - 2. Feedback and Discussion:

- a. President Harper spoke in support of the resolution and the importance of a resolution such as this for future presidents to understand and ensure shared governance and for the handbook to be looked at by the faculty periodically to ensure it is up to date with the current structure of the university.
- b. Guest R. LaFever read a statement regarding the resolution stating that the actions and inactions of the administration have amplified CSUB's liability, culpability, and institutional shame. He shared that he has engaged in many conversations with students, faculty, staff, community members, and administrators and submitted a vote of no confidence to the Executive Committee, which was not brought to Senate. He agreed that the call for an investigation into the administration's handling of the softball matter is a good first step. He stated that while President Harper has recently tried to establish transparency around the softball situation, it should have been provided prior to September 8. The administration holds the ultimate authority, and the role of the Senate is to ensure that this authority is exercised reasonably and in a manner consistent with policies and procedures established though shared governance. He stated that while the President is eager to reaffirm his commitment to shared governance, that faculty leadership on campus should reaffirm their commitment to oversee the management of the university and not shy away from criticism.
- c. Guest A. Gebauer spoke that while faculty members are all in support of shared governance, actions need to be taken. It has become practice for administrators to believe that informing the Executive Committee of an action is shared governance, however it is not, as the Executive Committee does not speak for the Senate. There has been an unprecedented number of administrator appointments without searches and an unprecedented number of administrators being promoted to new positions that do not exist, which is deeply concerning. Senator Grombly responded that there is more in the works regarding this resolution.
- d. Vice-Chair Solano suggested the addition of some language regarding confidential discussions and the avoidance of that as much as possible.
- e. Senator Roberts spoke in support of more specific details as there are varying degrees and levels to transparency. Senator Roberts also spoke regarding the filtration of information through Executive Committee as problematic.
- ii. RES 252606 Call for a CSU Chancellor's Office Investigation Regarding Recent Incidents in Athletics EC (handout)
  - 1. Chair Danforth and Senator Grombly presented the resolution for first reading.
  - 2. Feedback and Discussion:
    - a. Senator Grombly spoke to recognizing that there are limits to what can be disclosed in criminal and personnel investigations, however, there is a need for reassurance that proper process was followed. Senator Grombly also spoke regarding the cost of an investigation and the involvement of the Chancellor's Office.
    - b. Senator Zenko spoke in support of the resolution and if additional checks and fact findings result in verifiable evidence being found, he is in support of that.

- Senator Zenko also spoke regarding the burden of receiving confidential information and how it places members of EC in a very difficult position.
- c. President Harper spoke in support of the resolution and said that he had not thought about the burden on Executive Committee for sharing confidential information and that he would do his best to reduce the burden going forward. He will work with L. Blodorn for communication with the Chancellor's Office and the possibility of accelerating this request.
- d. Senator Stokes asked about what these types of investigations look like. VP L. Blodorn has not had a conversation yet with the Chancellor's Office, however, it would be under Audit and Advisory services. L. Blodorn and Chief Gonzalez spoke in support of the investigation.
- e. Senator Tsantsoulas reaffirmed the comments made by other Executive Committee members and encouraged all to remain intentional to ensure that all faculty and the entire Senate feel involved and informed as much as possible.
- f. Senator Reyes thanked Executive Committee for bringing the resolution forward and shared concerns with the CSU, which have had a history of mishandling these types of investigations and sexual harassment scandals.
- g. Senator Lauer followed up regarding if an outside investigator was considered. Senator Zenko responded that yes, extensive discussion took place, however, it is not financially feasible to contract an outside firm.
- h. President Harper suggested reviewing the Audit and Advisory services page on the CSU Chancellor's Office webpage. Institutions can ask for a specialized audit or review of a particular area, and he encouraged anyone interested to visit the website.
- i. Guest K. O'Bannon asked if there was any conflict with running this investigation at the same time the civil lawsuit is happening. L. Blodorn responded that they would need to consult the general counsel and reminded the audience that everyone has the constitutional right to privacy of personal information and there are always going to be things that cannot be shared.
- j. Guest A. Gebauer spoke regarding how the media has negatively shaped the discussion and environment surrounding this issue and reaffirmed that stronger administrative action and leadership would have prevented this.
- k. Senate Parliamentarian A. Hegde asked if it can be found out in advance if the Chancellor's Office would agree to this investigation? VP L. Blodorn said that yes, then can determine if an outside firm would be necessary or not and she can report to Senate what the response is.

#### VII. Open Forum (Time Certain: 11:15 AM)

- a. Senator Lauer voiced concerns that Facilities are still blowing dust and putting students, staff and faculty at risk of contracting Valley Fever and the need for a written policy.
  - i. President Harper suggested the concern be brought to the Ecosystems Advisory Council.
- b. Senator Sarma provided information on a business leaders panel discussion.

- c. Senator Dong invited attendees to the CERC event on October 16 at 3 PM in the Dezember Reading Room. Other upcoming NSME events include Geology Day on October 17 and Chemistry Day on October 24, with both events having over 200 children visiting.
- d. Senator Reyes shared that ASI will be hosting an event on October 23, Voices in Local Politics, and asked if anyone would like to participate, to contact him.
- e. Senator Lauer invited attendees to the upcoming Sustainability Events on October 15 from 11 AM to 1 PM outside of the Student Union.
- f. Provost Thien reminded Senators and guests to send events to <a href="mailto:provost@csub.edu">provost@csub.edu</a> for inclusion in the Blue and Gold Bulletin.
- g. Emergency Evacuation Drill: Chair Danforth commented on the recent issues with the emergency evacuation drill. Chief Mari Gonzalez confirmed that the vendor was having issues, and they are looking at using other vendors. Senator Lam added that the speakers are very loud, however, the audio quality is bad, and listeners cannot hear what is being said. Chief Mari Gonazalez said that James Morrison from the Emergency Operations Center, is collecting details to look in to fixing this issue. Senators Reyes and Michieka added that no alarms went off in the Student Union or Library.
- h. President Harper thanked Professors Gebauer and LaFever for their attention to these matters in Athletics and on campus and encouraged continued engagement and commitment to the values of the institution.
- i. Chair Danforth reminded attendees of the upcoming town halls scheduled for Friday, October 10.
