- Title IX Process – Chancellor Castro resigned because of circumstances at Fresno State, especially dealing with Title IX. To make sure those things don't happen at CSUB, M. Brown, Deputy Title IX Officer was asked to talk to the Senate about timeline, processes, etc. (A. Hegde) Campuses can falter where there is a gap in access to resources, support, and the enforcement of policy. Find *Title IX Team* presentation attached to the minutes. Comment to M. Brown: Since Title IX covers employees, please talk to the schools about hostile work environment and do some listening. (J. Tarjan) Who does M. Brown report to? (E. Correa) A: M. Brown reports to C. Catota. Title IX, in its confidentiality, is governed by the Executive Orders 1096, and 1097 from the Chancellor's Office (CO). (M. Brown)
- Enrollment Spring '22, Fall '22 – D. Cantrell – Find D. Cantrell's *Spring Enrollment 2022* presentation and *Spring 2022 Preliminary Data* attached to these minutes. Enrollment funnel: our new process allows us to admit more than we ever have due to our more efficient processes. Total number of applicants by term, total number by school and term, total number by applicants by ethnicity, total number of AV applications, total number of admitted by term, total number of admitted student by school and by term are in the presentation slides. Q: What percent of admitted students end up enrolling? A: 80-85% of those who express intent to enroll end up enrolling and approximately 18% of those admitted end up enrolling. We can help students with their intent to enroll and implementation. (D. Cantrell) Comment: Develop a campus-wide Strategic Enrollment Management mindset: The number of enrolled students impacts the Budget, School and Course Planning, Human Resources, the System Enterprise and Student Services. Best practice guideline is 1/1000 counselor to student ratio. We're now 1/2000 counselor to student ratio. (J. Millar)

RES 212222 Academic Calendar 2022-23 Academic Advising edit Fall 2022

New Business

RES 212220 – Formation of General Studies (GST) Review Committee – J.

Tarjan presented on behalf of AAC. There are adjunct faculty who are teaching courses who are not in a regular academic department. Hence, they don't have a home for classroom observation and review as far as advising faculty in terms of retention. The resolution attempts to address the shortcomings in our operations. The Associate Deans are making those appointments of GST instructors where there isn't an academic department.

The group to whom advice would be given would depend on where those appointment lay. Q: The Handbook indicates that faculty must have a home.

Is this a matter of not adhering to process? (M. Danforth) A: The idea is that they'd be given an academic home. Most people teaching First Year Seminar (FYS) are staff positions, counselors, advisors, librarians, and others who don't have a department and are not going through classroom observation,

etc. Example: E. Callahan has an administrative appointment and is not part of any academic home. She's a great instructor. There are maybe two who would request an annual review, but they don't have a home from which to be reviewed. (J. Tarjan) Comment: An academic home is necessary from a CBA perspective. There's a review process but not an academic home. (V. Harper) Feedback to AAC: remove "librarians" as they have a home and a process. (A. Grombly) Define academic home in terms of the CBA. A department or program committee is not an academic home. Instructors who are not connected to a department usually teach FYS just once a year, so they don't go through a review. (M. Rees) Academic home is a euphemism. (J. Tarjan) Feedback to AAC: The Counseling Center is a home for the counselor faculty who teach GST courses. The increase in students hasn't allowed counselors to teach FYS. The course is an important way for students to interact with counseling to develop trust with people. Counseling has a unit committee for process and review. (J. Millar) Faculty should have input on the

hiring of faculty and there should be some unit charge, such as with GST faculty. It's an attempt to give those who want a review an entity they could ask for it. If a department doesn't hire that faculty member, do they have a say on retention? This is AAC's attempt to fill the gap. AAC is open to other suggestions. (J. Tarjan) Thank you to J. Tarjan for tackling a very difficult problem. It's a step in the right direction. (V. Harper) Additional feedback can be sent to J. Tarjan. (A. Hegde)

RES 212221 Academic Calendar – Fall Recess Schedule – C. Lam presented on behalf of BPC. There was a referral to consider a full week break in Fall term. There are consequences to that approach that impact teaching days at the end of the Fall semester. The survey of Fall breaks at other CSU campuses was considered. BPC's resolution is to add a Wednesday recess before Thanksgiving Break. (C. Lam) The issue came from a suggestion from Senator Rodriguez. BPC, who is tasked with the Academic Calendar, had a healthy discussion about adding a recess without moving University Week. This is their proposal. There's a possibility of it being discussed again. (A. Hegde) The streamlining of University Week is important because of concern for the students. During the pandemic, it was very difficult for parents who had children at home. Some had to quit their jobs. Public schools have the whole Thanksgiving week off. Our most vulnerable students have to find childcare or not go to class at all. (A. Rodriguez) By having an extra day to Thanksgiving Break, we're assuming we're not making any changes to University Week. If we want a full week without touching University Week, we'd have to push final exams and graduation to December 22<sup>nd</sup> and December 23<sup>rd</sup>. (C. Lam) The maximum faculty can work under the CBA is 180 days. (A. Hegde) Because we do not align with Public Schools, we'll lose our average daily attendance. Another rationale is the safety of students travelling so close to Thanksgiving. (J. Tarjan) It will be an ongoing conversation. (A. Hegde)

#### Old Business

RES 212218 Final Exam Policy – Interim Policy Change – C. Lam reminded Senators that there are some conflicts between final exams and commencement. It affects students and faculty. Because the Academic Calendar has been set for this year and next, this is an interim solution. (C.

Lam) Q: Why not set graduation a week after finals? (A. Lauer) A: BPC just received a referral to look at Saturday Commencement. (C. Lam) Moving commencement out is not an option. Black and Hispanic graduation do not involved tickets. Ask people who are involved in these events. (T. Salisbury) J. Tarjan in strong support of the resolution. Speaking to the Senate Chair – there seems to be a lot of external constraints on the academic calendar where we cancelled the reading day, where our commencement is smashed against final exams, etc. Perhaps take it forward that the current work calendar doesn't allow the flexibility to meet our students needs to celebrate their accomplishments as well as the academic and intellectual needs of our students. We do these things because of external constraints. (J. Tarjan) That is a task for BPC and hopefully they'll bring something forward. (A. Hegde) A vote was called. Approved.

RES 212219 Submission of Electronic Faculty Performance Files – M. Rees reminded the body that the resolution is to form a task force to investigate software to support the RTP process. There are problems with Box especially for lecturer use. This is to get started on finding a better solution. There were no changes from the First Reading. A vote resulted in approval.

#### 9. Open Forum Items

- Performance of systems in classrooms – In response to Senators Street and Rodriquez, ITS updated four locations where they found older hardware. ITS hopes to have systems upgraded in 48 classrooms by Fall. There are 60 departmental labs and spaces that ITS will discuss with the deans. ITS is responsible for all the equipment in Academic Operations, but we need to figure out how to get computers updated in other spaces. (F. Gorham)
- ITS Consultation for RTP software – F. Gorham offered any assistance.

# Title IX Reminders

## Duty to Report - Upon Disclosure

- Gather basic info (5Ws)
- Assess “support” needs
- **REPORT** (to Title IX Coord.) and **REFER**
- Maintain confidentiality; written and verbal (need to know basis)
- Take necessary action, not retaliatory action (seek counsel)
- Document actions



# Title IX Process

## **\*\*Duty to Report**

- Formal process begins when the Title IX Coordinator receives a written Complaint from Complainant.
- Investigations can take several months.
- Confidentiality – need-to-know basis.
- Interim accommodations may be necessary.
- **\*\***Personnel management may still occur but may require check-in with Title IX Coordinator.




# CSUB SEM VISION
